There is a strong interest in combining the presence of academics, professionals from the field of transport as well as members of Public Agencies with competence in transport matters.

Academics and professionals interested in presenting a paper to the Conference are kindly invited to submit the <u>title and an abstract before 15 May 2022</u> and the full text of the paper before 15 July 2022.

Confirmation of acceptance (or refusal) will be sent in writing within 20 days from the expiry of the deadline for the submission of the full text of the paper. Acceptance does not necessarily imply the publication of the paper in the Conference proceedings.

In order to include the paper in the Conference proceedings, it shall not exceed 25 pages and adjust to the model that will be published within short on the Institute's website (www.idt.uji.es). The papers shall include the name of their author/s, the academic filiation or post, as well as a contact address (e-mail). The oral presentation of the paper shall not exceed fifteen minutes.

Papers may address any topic related to the transport sector.

To promote excellence of the papers, the Institute will grant the VI IDT Awards to the Best Papers: a first prize, endowed with 600 euros; a second prize, endowed with 300 euros; and a third prize, endowed with 170 euros. The prizes will be given in a public session before the closure of the Conference and may be awarded *ex aequo*. Participation is open to all those unpublished papers that fulfil the above conditions and are presented orally during one of the Conference paper sessions.

The organization reserves the right to publish the winning papers. Members of the Scientific Committee are excluded from the award.
